



Hornsea Sailing Club Streaker Class Open Meeting

Notice of Race

14th April 2012

1 Rules

The Racing and conduct of the event will be governed by the 'Rules' as defined in the Racing Rules of Sailing (RRS) 2009-2012 except as they are changed by the Hornsea SC sailing instructions, class rules, the prescriptions of the RYA and this Notice of Race.

Any change to the sailing instructions will be posted on the official class notice board on the day it will take effect. In addition two sound signals will be made and flag 'L' flown from the Club flagstaff.

2 Conditions of Entry

- 2.1 The safety of the boat and its entire management, including insurance shall be the sole responsibility of the competitor(s) racing the boat.
- 2.2 All craft on the club premises (on land and on the water) must have full insurance cover, including third party liability to £2,000,000. All craft intended to be used for racing must have appropriate insurance cover.
- 2.3 The race organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/competitor, his skipper or crew, as a result of their taking part in the race or races. Moreover, every owner/competitor warrants the suitability of his yacht for the race or races.

3 Organisers:

The organisers are Hornsea Sailing Club.

4 Entry and Registration

- 4.1 The entry fee for the event will be £10
- 4.2 Boats shall be entered by completing registration with the organisers requiring:
 - A completed entry form and entry fee (available on the day)

- To be in possession of a valid and current Streaker membership certificate/transom sticker
- To be in possession of a valid boat Registration Certificate.
- To have in place valid third party insurance to a minimum of £2,000,000

5 Event and Programme

- 5.1 Sailing will take place on Hornsea Mere, a natural inland lake of approx 250 acres in East Yorkshire, close to the North Sea coast. The Mere has two distinct areas of shallows which are marked, but competitors are advised that fixed rudders may cause problems. The Mere enjoys generally fairly clear winds which can be affected by a sea breeze in the afternoons.
- 5.2 There will be a briefing for all competitors no earlier than 11 am on Saturday 14th April 2012 and prize-giving will be after the final race
- 5.3 3 races will be scheduled of which a minimum of 2 will constitute a series. If 3 races are sailed 2 will count. If 2 races are sailed, both will count.
- 5.4 The first race will start no earlier than 11.30am on Saturday 14th April 2012.
- 5.5 There is **no camping/overnight stopping available on site**. However there is a site close by at The White Cottage (it overlooks the Mere) details available on our website. There are numerous B&B and other accommodation possibilities (eg static caravans) nearby.

6 Advertising and Sponsorship

Advertising will be restricted to that allowed by the Streaker Class Association section 10:

7 The Course

The courses will be set on Hornsea Mere.

8 Scoring

Points

The low point scoring system will apply as set out in RRS A4.1. Additionally:-

- Retirement or Did not Finish (DNF) points equal to the number of starters plus 1.

- Did not start (DNS) points equal to the number series entry plus 1.
- Disqualification points equal to the number of starters plus 6. This changes RRS A9.
- Did not compete (DNC) points equal to series entry plus 6. This changes RRS A9.
